By participating in the raffle, you agree to the following contest rules:

These **OFFICIAL CONTEST RULES** govern the conduct of the raffle, hereinafter referred to as the **Lou Fusz Soccer Club Car Raffle**, and are binding on everyone who purchases a raffle ticket and/or who is named on a raffle ticket. This is made possible by Lou Fusz Automotive Network and Lou Fusz Soccer Club. These official contest rules may not be waived, modified, or supplemented except by Lou Fusz Soccer Club Director Don Popovic with the approval of Lou Fusz.

By participating in this raffle, all ticket purchasers and everyone named on a raffle ticket accept and agree (1) to be bound by all the rules, limitations, and restrictions set forth here, and (2) that their names and/or likenesses may be disclosed to and used by the news media and may otherwise be used by Lou Fusz Soccer Club, and Lou Fusz Automotive Network for publicity purposes in area newspapers or other media including the Lou Fusz Soccer Club, and Lou Fusz Automotive Network websites.

By participating in this raffle, each participant releases Lou Fusz Soccer Club and each of its directors, officers, employees, and agents, as well as Lou Fusz Automotive Network, and each of its directors, officers, employees, and agents, from any and all liability for injuries, losses, or damages of any kind caused by any prize or resulting from acceptance, possession, use or misuse of any prize, and the winner agrees to indemnify and hold Lou Fusz Soccer Club, and Lou Fusz Automotive Network, and each of its respective directors, officers, employees, and agents harmless from any and all losses, damages, costs, expenses, rights, claims, and actions of any kind arising in connection with or as a result of the winner's acceptance or use of the prize. Sponsor will not be responsible for typographical, printing or other inadvertent errors in these Official Rules or in any announcements or other materials related to the Giveaway.

**Tickets:** The price per ticket is \$10.00 and may be purchased from an individual player or directly from Lou Fusz Soccer Club. Each raffle ticket will be entered separately in the drawing and has a separate and equal chance to win. Any raffle ticket that is deemed in Lou Fusz Soccer club's discretion to be defective or illegible will not be honored. *The IRS position is that amounts paid for chances in raffles, lotteries, or similar drawings for valuable prizes are not gifts and consequently do not qualify as deductible charitable contributions.*

Tickets will be sold until noon of the day the drawing will be held. The prize drawing is open to the public, but the winner does not need to be present to win. No additional prizes will be awarded. Raffle tickets, including the winning ticket, have no cash value.

**Eligibility:** Raffle ticket purchasers and the person named on a raffle ticket must be at least 18 years of age at the time of purchase. A raffle ticket can be purchased in one name only. Raffle tickets may not be purchased in the name of a member of the Board of Directors of Lou Fusz Soccer Club (or persons residing in the same household as Board of Directors). The prize winner may be required to sign an affidavit of eligibility.

**Refunds:** All raffle ticket sales are final. No refunds or exchanges will be made. Lou Fusz Soccer Club assumes no responsibility for lost, stolen, or damaged tickets, or for late, misdirected or non-delivered mail, fax messages, or any other failure to receive ticket purchases receipts prior to the drawing deadline. In no event shall Lou Fusz Soccer Club, Lou Fusz Automotive Network or their respective directors, officers, employees, members, committee members, agents or representatives be liable to any party for any loss or injuries to earnings, profits or goodwill or for any incidental, special, punitive or consequential damages of any person or entity under any circumstances.

**Drawing:** The drawing for a \$30,000.00 new automobile or \$30,000.00 credit towards a new automobile from any Lou Fusz Automotive Network dealership will be held the first week of April, 2015. Lou Fusz Soccer Club will make reasonable efforts to contact the person named on the winning raffle ticket (who does not have to be present to win) using only the information on the winning raffle ticket form.
